3	Rule 201, which provides:			
4	The Court may judicially notice a fact that is not subject			
5	to reasonable dispute because it: (2) can be accurately and readily determined from sources who			
6	accuracy cannot reasonably be questioned.			
7	Fed.R.Evid. 201(b)(2).			
8	To determine the accuracy of Exhibit C, D, and F to the Verified			
9	Complaint, one need only go to the website for the Washington Secretary of State,			
10	https://www.sos.wa.gov/corps/, run a business search for Enterprise Focus, Inc.,			
11	Giga Watt, Inc. and Clever Capital LLC and review the filing history for each			
12	entity. The documents are listed by date and available to the public for free.
