

1. The Motion is Granted.
2. Attorney *Alan R. Dolinko* is admitted to appear before this Court in this adversary proceeding as counsel for *Mark A. Sellers, Jack H. Jacobs and Sellers Capital, LLC* subject to Local Rule 2090-1.
3. Within fourteen days from the date of this order, attorney *Alan R. Dolinko* shall pay to the Clerk, of the United States District Court for the Middle District of Florida, an Attorney Special Admission Fee in the amount of \$150.00 and upon payment of the fee, file a Notice of Compliance with the Clerk of the U.S. Bankruptcy Court. 4. Upon completion of the Court's electronic filing registration forms and requirements, the Clerk is directed to issue attorney *Alan R. Dolinko* , a temporary login and password to the Court's electronic filing system (CM/ECF) with filing privileges limited to this case and any related adversary proceedings. PACER accounts required for viewing, must be set up by the attorney through PACER at <http://www.pacer.gov>.
